Terms and Conditions

The Rehoming Provider has agreed to participate in the Greyhound Racing New South Wales (**GRNSW**) Rehoming Contribution Scheme (**Scheme**), subject to the terms and conditions set out below (**Agreement**).

1. GRNSW will agree to provide funding to the Rehoming Provider's nominated veterinarian in an amount of \$350 (including GST) (**Funding**) subject to the following conditions:

- a. Only greyhounds that have attained 'Greenhound' status will be eligible to participate in the Scheme, being:
 - i. greyhounds that have successfully completed an approved greyhound retraining program as determined by a person authorised in accordance with clause 33B(1)(a) of the *Companion Animals Regulation 2008* to conduct a behavioural assessment of a greyhound (**Approved Assessor**); and
 - ii. greyhounds that are no longer required to wear a muzzle in a public place in accordance with section 15 of the *Companion Animals Act 1998 (NSW)*;

(hereafter referred to as **Greenhound**)

- b. A 'GRNSW Notification of Retirement Form' has been submitted by the last registered owner of the greyhound in accordance with National Rule 106(3) of the Greyhound Racing Rules and this Notification of Retirement Form has been received by GRNSW; and
- c. The Rehoming Provider satisfactorily completes and submits to GRNSW a 'GRNSW Application for Rehoming Contribution Scheme Form'

2. The Rehoming Provider must present upon GRNSW's request, a tax invoice from the Rehoming Provider's nominated veterinarian which specifies:

- (1) the veterinarian's fees for services performed; and
- (2) any additional information required by law or pursuant to the Australian Taxation Office guidelines to qualify as a tax invoice for the purposes of the *A New Tax System (Goods and Services Tax) Act 1999 (Cth)*.

3. GRNSW will undertake a review of the Scheme and Funding on a yearly basis, and reserves its rights to terminate the Scheme and Funding at any time, without notice.

4. In making an application to participate in the Scheme, the Rehoming Provider agrees to comply with all reasonable requests from GRNSW for information concerning matters relating to greyhounds.

5. The Rehoming Provider must ensure that the Scheme is performed in accordance with all applicable laws, regulations and standards.

6. The Rehoming Provider does not have the right or authority to act on GRNSW's behalf, bind GRNSW or speak on behalf of GRNSW.

7. The Rehoming Provider acknowledges, that as an independent contractor it is responsible for undertaking the Scheme and associated activities.

8. The Rehoming Provider is responsible for any loss, damage to GRNSW or any third party arising from any breach of this Agreement or any act, negligence or omission of the Rehoming Provider.

9. The Rehoming Provider will indemnify GRNSW against all liability whatsoever arising out of this Agreement, that arises from the Scheme, or as a consequence of the actions of the Rehoming Provider and/or its employees or agents.

10. GRNSW may terminate this Agreement on one month's written notice.

11. The Rehoming Provider agrees not assign, novate or sub-licence their rights or obligations under this Agreement.

12. This Agreement is governed by the laws of New South Wales.
